Programme Structure:

Module 1: Co-creating an end to end transformation programme for your organisation

This element of the programme will support delegates to bring together their thinking to create a clear, integrated and ambitious strategic roadmap, and understand what success will look like. It will cover areas such as:

- What does the future look like?
- How will we maximise your value proposition?
- How will we align the future transformation plan with your people, processes and technical capabilities?
- What sources and routes to funding might be available/appropriate to support your plans?
- How can we align your sustainability goals with your vision?

Module 2: Processes and people

This element will allow attendees to undertake a deep dive of their existing processes and the people who support them, to enable the achievement of long term change success. Specifically:

- How do you create a plan using a change management framework?
- How do you communicate the vision?
- How are you going to measure and monitor your progress and success?
- How can you improve your processes and structures to enable short term wins?

Module 3: Embedding good governance

This element will support businesses to implement effective change management and de-risk growth opportunities by ensuring good governance is embedded throughout the organisation. It will address key questions such as:

- Do you have the capital and talent you need to implement your growth strategy?
- How do you establish robust financial plans?
- Is your organisational design and governance framework appropriate?
- What structure do you need to adapt your plan as you go?
- How do you create the right culture for success?
